Acknowledgment of Risk

I hereby acknowledge and agree that participation in activities at, and use of, the Lonetree Reservoir ("Reservoir")comes with inherent risks. I have full knowledge and understanding of the inherent risks associated with accessing the Reservoir and any and all recreational activities thereon or around, including but in no way limited to: (1) slips, trips, and falls, (2) aquatic injuries, (3) athletic injuries, (4) boating and watercraft injuries and accidents, and (5) illness, including exposure to and infection from viruses or bacteria. I further acknowledge that the preceding list is not inclusive of all possible risks associated with accessing and using the Reservoir and that said list in no way limits the operation of this Agreement.

Coronavirus / COVID-19 Warning & Disclaimer
